2. E-Shram Card Registration

- ➤ Objective: To register unorganized workers under the national E-Shram portal for social security.
- Activities: Organized 10+ camps across villages and semi-urban areas; collaborated with local panchayats and labour offices.
- ➤ Impact: Registered over 5000+ workers, linking them to government welfare schemes and insurance benefits.

3. PM Vishwakarma Yojana

- ➤ Objective: To empower traditional artisans and craftspeople through skill development and formal recognition.
- Activities: Mobilized artisans through community outreach; helped 1,800+ applicants with onboarding and documentation.




